I am pleased to advise that on 1 July 2022, WA joined the Uniform Law scheme. This exciting milestone has brought 75% of all legal practitioners Australia-wide under the Uniform Law scheme, as shown in the infograph below. This is a significant step towards the goal of Australia having a national legal profession which operates under a national regulatory framework.

Recently, as part of celebrating this occasion, the Legal Services Council (Council, LSC) was pleased to hold our fourth annual Uniform Law Summit and a Uniform Law Dinner in Perth. The Summit and Dinner were both a success and showcased the collegiate relationships that exist across the Uniform Law




jurisdictions. The progress made by Western Australia in this transition was also demonstrated, as well as the assistance that the NSW and Victorian designated local regulatory authorities have and will continue to provide to WA, as they implement the Uniform Law scheme.

# Update on WA joining the Uniform Law scheme

On 1 July 2022, the <u>Legal Profession Uniform Law Application</u> <u>Act 2022 (WA)</u> was proclaimed, marking the commencement of the Uniform Law in WA. The proclamation is available <u>here</u>.

The Legal Profession Uniform Law Application Regulations 2022 (WA) and the Legal Profession Uniform Law Application (Accreditation) Rules 2022 (WA) also came into operation on that day.

The commencement of the Uniform Law in Western Australia was accompanied by the commencement of Part 2 of the <u>Legal</u> <u>Profession Uniform Law Application Amendment Act 2019</u> (Vic), which provides for governance changes to the Council and Admissions Committee to reflect the participation of a third jurisdiction in the Uniform Law scheme. #### Law Society of Western Australia's Uniform Law article

The Legal Services Council recently published an article in the Law Society of Western Australia's June edition of its publication *Brief*, marking WA joining the Uniform Law scheme. The article, drafted by Chelly Milliken, Senior Principal Policy Officer is available <u>here</u>.

Topics covered were Western Australia's inclusion in the Australian Legal Practitioners Register and linking WA's Register of Disciplinary Action; the Legal Practice Board of Western Australia's Register of Delegations on the LSC's website; a WA Public Register of External Examiners and various Uniform Law Guidelines and Directions.

The meeting progressed various operational aspects of WA's entry in the Uniform Law scheme and is part of a continuing dialogue between the LSC and Legal Practice Board of Western Australia that will continue over the coming months.

The Summit was an important opportunity for attendees to meet their counterparts in other Uniform Law jurisdictions, hear about their roles and work and to celebrate the cooperation and collaboration that exists in the Uniform Law scheme. Our next Uniform Law Summit will take place in Melbourne in the second half of 2023.

### **Uniform Law Dinner**

As part of our recent trip to Perth, the Council hosted a Uniform Law dinner to mark the historic occasion of Western Australia joining the Uniform Law scheme on 1 July 2022. The Attorney General of Western Australia, the Hon John Quigley LLB JP MLA, was our guest speaker.

In his opening remarks, the Council's Chair, Alan Cameron AO thanked the Western Australian Attorney General for his endorsement of the dinner and other related Uniform Law events held by the Council in Perth at the time, and for accepting our invitation to be our guest speaker.

Alan Cameron AO acknowledged the inaugural Council Chair, Michael Black AC QC FAAL and the first CEO/Commissioner, Dale Boucher, together with the former Council members for their invaluable work in establishing the Council, in terms of its structure, operations and sound reputation.

In introducing the guest speaker, Alan Cameron AO highlighted the visionary leadership and active involvement of the Attorney General of Western Australia in achieving this milestone and the support of the Attorneys General of NSW and Victoria.

He also acknowledged the Council's former and current observers from Western Australia, the current Chief Justice, the Hon Peter Quinlan, when he was the Solicitor General of Western Australia, and the current Solicitor General of Western Australia, Joshua Thomson SC for their significant contributions. The valuable work of the current Western Australian observer on the Admissions Committee, the Hon Rene Le Miere QC, was also highlighted.

The Legal Practice Board of Western Australia and the Legal Profession Complaints Committee were also congratulated for their work behind the scenes and for their collaboration with the Uniform Law regulators in NSW and Victoria, whose contributions were also recognised.

The Attorney General gave a highly engaging and informative speech that provided insights into his positive views about the Uniform Law scheme, its benefits for the legal profession in Western Australia and the future expansion of the scheme into other jurisdictions.

The Attorney General also noted that Western Australia's entry into the scheme ensured that 75% of the Australian legal profession would now be covered by the Uniform Law and that this represented a significant step towards the goal of Australia having a national legal profession, operating under a national regulatory framework.

The Council was delighted that over 60 people including members

of the judiciary and the legal profession, departmental officers, representatives of Uniform Law bodies, legal professional associations, and stakeholders from Sydney, Melbourne, Canberra and Perth were able to attend the dinner.

This dinner was an excellent opportunity to bring all the key stakeholders in the Uniform Law scheme together, to celebrate this tremendous milestone. The Council, its CEO/Commissioner, its Admissions Committee and Secretariat were very pleased to meet our key stakeholders in person at the dinner and to discuss Uniform Law matters with them. In particular, the dinner enabled the Council's guests from Western Australia to be introduced to others in the Uniform Law scheme and to become more familiar with the Uniform Law framework.

From all accounts, the dinner was a great success and paved the way for Western Australia's entry into the Uniform Law scheme on 1 July 2022.

#### Law Society of Western Australia – Uniform Law seminar

On 6 July, the Law Society of Western Australia hosted a seminar on the Uniform Law scheme for legal practitioners in WA. Craig Slater, barrister and former President of the Law Society introduced a panel of speakers comprising the Legal Service Council's Chair, Alan Cameron AO and CEO/Commissioner, Megan Pitt and Libby Fulham, Executive Director and Russell Daily, Law Complaints Officer from the Legal Practice Board of Western Australia. The seminar was attended by 285 Western Australian solicitors and barristers, 25 in person and 260 by webinar.

The Council's Chair welcomed Western Australian's legal practitioners to the scheme and congratulated the Law Society of Western Australia on hosting this seminar and other related CPD events, and on providing materials to assist the legal profession to understand the Uniform Law scheme.

An overview of the Uniform Law framework, its key bodies, the role of the Council and its interaction with the Legal Practice Board of Western Australia was provided by Megan Pitt. She also emphasised that the Council is not a regulator and that, although the scheme does involve some changes, many of the current features of legal regulation in Western Australia will remain the same.
