Appointment of new Council members

Costs disclosure thresholds review

On 30 September 2022 the Council announced a review of the costs disclosure thresholds in the Legal Profession Uniform Law. The Council appointed Dr Matthew Butlin as an independent expert consultant to lead the Review and to provide a report to the Council. The Review will take an evidence-based approach to consider the effectiveness and regulatory impact of the costs disclosure thresholds, including how they measure up against the objectives of the Uniform Law. The Review may make recommendations for amendments to the Legal Profession Uniform General Rules, the costs disclosure forms and information sheets, and the Guidelines and Directions on costs estimates

The Review team has been meeting with designated local regulatory authorities, professional associations and departments in participating jurisdictions during November and December

and we are grateful for your feedback and assistance. We look forward to meeting with regulators and professional associations in the non-participating jurisdictions and consumer organisations early next year and to releasing an options paper.

Conference of Regulatory Officers

From 2 to 4 November 2022 the Council's policy team attended the highly-anticipated National Conference of Regulatory Officers in Brisbane, hosted by the Queensland Legal Services Commission, Queensland Law Society and Bar Association of Queensland. The CORO program offered insights into the changing world of legal services delivery and how they are consumed. It also provided valuable opportunities to meet or catch up with colleagues and stakeholders from participating and non-participating jurisdictions.
